That pursuant to Section 10 (1)i & 10 (6)b of the Registered Club's Act 1976, the members hereby approve a sum not exceeding \$60,000 and agree to, the members of the Board and the other persons referred to below, during the period preceding the 2018 Annual General Meeting, receiving the following benefits and the members further acknowledge that the benefits outlined in sub-paragraphs (i) to (x) are not available to members generally but only to those members who are elected Directors of the Club and the other persons referred to below:
  - (i). The reasonable costs of meals and refreshments to be associated with each Board meeting of the Club:
  - (ii). The right for Directors to incur reasonable expenses in travelling to and from Director's meetings or to other constituted meetings as approved by the Board from time to time on the production of invoices, receipts or other proper documentary evidence of such expenditure;

# NOTICE OF SPECIAL RESOLUTION FOR ANNUAL GENERAL MEETING

**NOTICE** is hereby given that at the Annual General Meeting **WARILLA BOWLS & RECREATION CLUB LIMITED** to be held on **10 SEPTEMBER 2017** commencing at the hour of **9.30AM** at the premises of the Club, Jason Avenue, Barrack Heights, New South Wales, the members will be asked to consider and if thought fit pass the two (2) Special Resolutions set out below:

#### PROCEDURAL MATTERS

- To be passed a Special Resolution must receive votes in favour from not less than three quarters (75%) of those members who, being eligible to do so, vote in person on the Special Resolution at the meeting.
- Only Life members and financial Bowling members shall be eligible to vote on the Special Resolution.
- Under the Registered Clubs Act:
  - (a) members who are employees of the Club are not entitled to vote; and
  - (b) proxy voting is prohibited.
- Amendments to the Special Resolution (other than minor typographical corrections which
  do not change the substance or effect of the Special Resolution) will not be permitted
  from the floor of the meeting.
- The Board of the Club recommends each of the Special Resolutions to members.

## **FIRST SPECIAL RESOLUTION**

[The First Special Resolution is to be read in conjunction with the notes to members set out below.]

That with effect from and for the purposes of the Annual General Meeting to be held in 2017, the Constitution of Warilla Bowls & Recreation Club Limited be amended by:

(a) deleting Sub-Rules 3(1)(l)(iii) and (iv) from the definition of "Home Club Member" in Rule 3(1)(d) so that it provides:

""Home Club Member" shall mean any Bowling member who has either the:

- (i) Warilla Men's Bowling Club; or
- (ii) Warilla Women's Bowling Club,

nominated or declared as their "home club" for the purposes of their membership with the Royal New South Wales Bowling Association or the New South Wales Women's' Bowling Association."

(b) deleting from Rule 9.5 the reference "2(b)" and in its place inserting the reference "2";

- (c) deleting Rule 10.1 and renumbering the remaining provisions of Rule 10;
- **(d) inserting** into Rule 24.4 the word "nominate," after the words "shall not be eligible to" so that Rule 24.4 provides:

#### "24.4 A member who is:

- (a) an employee; or
- (b) who is currently under suspension pursuant to Rule 20;
- (c) is not a Financial member

shall not be eligible to nominate any member for election to, stand for or be elected or appointed to the Board."

- **(e) deleting** from Rule 27.3 the words "the Deputy Chairperson" where they appear and in their place **inserting** the words "a Deputy Chairperson";
- **(f) deleting** from Rule 27.4 the words "personally present" and in their place **inserting** the words "of the Board" so that Rule 27.4 provides:
  - "27.4 The quorum for meetings of the Board shall be a majority of the directors of the Board;"
- (g) deleting from Rule 28.5 the reference "clause 47G of the Regulations" and in its place inserting the reference "clause 20 of the Regulations"
- (h) deleting from Rule 32.2 the word "Annual" and in its place inserting the word "Biennial";
- (i) deleting Rule 36.1 and in its place inserting the following new Rule 36.1

#### "36.1. The Board shall:

- (a) cause proper accounts and records to be kept with respect to the financial affairs of the Club in accordance with the Act and the Registered Clubs Act.
- (b) prepare, on a quarterly basis, financial statements that incorporate:
  - (i) the Club's profit and loss accounts and trading accounts for the quarter; and
  - (ii) a balance sheet as at the end of the quarter.
- (c) cause the financial statements referred to in paragraph (b) of this Rule to be submitted to a meeting of the Board.
- (d) make the financial statements referred to in paragraph (b) of this Rule available to members of the Club within forty-eight (48) hours of the statements being adopted by the Board.
- (e) indicate, by displaying a notice on the Club's premises and on the Club's website, how the members of the Club can access the financial statements referred to in paragraph (b) of this Rule.
- (f) provide a copy of the financial statements referred to in paragraph (b) of this Rule available to any member on the written request of the member.

#### **Notes to Members on the First Special Resolution**

- 1. Paragraph (a) deletes from the definition of "Home Club Member" references to the Shellharbour Men's Bowling Club and the Shellharbour Women's Bowling Club which are no longer required.
- 2. Paragraph (b) updates the Constitution to refer to an amended section of the *Gaming Machines Act 2001*.
- 3. Paragraph (c) deletes an existing provision which provides that the number of Full members of the Club shall not exceed the maximum number of Full members permitted by the *Registered Clubs Act*. In regard to this the *Registered Clubs Act* no longer prescribes a maximum number of Full members for registered clubs and as a result, this provision is no longer required.
- 4. Paragraph (d) amends the Constitution to provide that members of the Club who are: employees of the Club, unfinancial or suspended cannot nominate another member for election to the Board.
- 5. Paragraph (e) amends a typographical error in the Constitution which refers to the one Deputy Chairperson when the Board comprises of two (2) Deputy Chairpersons.
- 6. Paragraph (f) amends the Constitution to clarify that a quorum for a Board meeting is a majority of the directors of the Board.
- 7. Paragraph (g) updates the Constitution to refer to an amended regulation of the *Registered Clubs Regulations*.
- 8. Paragraph (g) updates the Constitution to reflect the Club's Biennial elections. That is, the Rules now provide that a director who is appointed to fill a casual vacancy shall hold office until the next Biennial General Meeting (and not the next Annual General Meeting at which there is no election).
- 9. Paragraph (h) amends existing provisions relating the accounts and reporting requirements of the Club to bring the Constitution into line with the *Corporations Act* and *Registered Clubs Act*.

### SECOND SPECIAL RESOLUTION

[The Second Special Resolution is to be read in conjunction with the notes to members set out below.]

That with effect from and for the purposes of the Annual General Meeting to be held in 2017, the Constitution of Warilla Bowls & Recreation Club Limited be amended by **deleting** Rule 33.4(a) and in its place **inserting** the following new Rule 33.4(a):

"33.4(a) Subject to this Rule 33, the Board must call and arrange to hold a general meeting of the Club on the request of members with at least 5% of the votes that may be cast at the general meeting."

#### **Notes to Members on Second Special Resolution**

- 1. The Second Special Resolution amends an existing provision relating to the calling of general meetings on the request of members to bring the Constitution into line with the *Corporations Act*. In this regard:
  - (a) Rule 33.4(a) provides that the Board must call and arrange to hold a general meeting of the Club on the request of members with at least five percent (5%) of the votes that may be cast at the general meeting or one hundred (100) members. This reflects the previous requirements contained in the *Corporations Act*; and
  - (b) The *Corporations Act* has been amended and now provides that directors are only required to call and arrange to hold a general meeting of the Club on the request of members with at least 5% of the votes that may be cast at the general meeting (and not on the request of one hundred (100) members).
  - (c) The Second Special Resolution proposes to amend Rule 33.4(a), so that it reflects the current requirements of the *Corporations Act*.

It gives me great pleasure to present my report to the members for 2016/17, a year in which I was called upon to replace longtime Chairman Steve Feeney after his sudden passing. Steve was the ultimate Club Chairman – a man who loved this Club and the local community, who always put the best interests of the Club first, who always took the time to talk to Club members and who was greatly respected and much adored by everyone at the Club. It's been a humbling task to follow on from such a consummate Chairman, but with the support of our hardworking Board, our management staff ably led by Phil and Dan, Tracy Girardot and our administration staff, all of our floor staff and our loyal members, it's been both rewarding and very satisfying. Thanks to everyone for that support and rest in peace Steve, you'll remain forever in our hearts here at your beloved Club.

The Club had a very good financial year, as detailed in the General Managers report. World Bowls Chairman John Bell calls Warilla Bowling Club "the best Bowling Club in the World" and when you consider the marvelous facility we have, our successes on the green, and the major tournaments we host every year, it's hard to argue anything else.

The Club, during the course of the year, has had conditions imposed upon its liquor license as a direct result of noise complaints from some new neighbours and has spent over \$800K on noise mitigation works in response to those complaints. To quote Steve Feeney from last year's annual report: "We have always been a good neighbour, no matter who our neighbours may be". These works are testament to the importance the Club's places upon being a good neighbour.

The Board is in the early planning stages of expanding the bowls lounge out over no 4 green (the remaining synthetic green), as well as providing additional cabins and accommodation infrastructure. Whilst a time frame has not yet been determined for the works, suffice to say it's an exciting project which I'm sure, once complete, will very much impress our members and guests.

To those members who passed away during the year, and to those members that lost loved ones, please accept my deepest sympathies.

Finally, to all our members, thank you for your continued support and I'm sure you share in the pride that comes from being the "best Bowling Club in the World".

#### **GENERAL MANAGER'S REPORT**

It is with pleasure that I present my report for the year ending 30 June 2017, another good trading year in which the Club posted a profit of \$1,062,539. The underlying profit for the year was approximately \$810,000 and the final profit for the year included adjustments relating to the sale of land at Shellharbour and a depreciation adjustment to the Club's poker machine ticketing system. The Club remains debt free and in a sound financial position.

The Club continues to improve upon the facilities we provide for the enjoyment of our members and guests. This year saw the completion of the cabins refurbishment, the purchase of 51 Jason Avenue for use as a holiday rental, a complete refurbishment of the first floor function rooms and noise mitigation works to the main lounge and children's playground, all paid for from Club funds.

The Club has also committed to the installation of a 314KW solar panel installation on the roof of the indoor green, and subject to council approval should be installed prior to Christmas this year. This will, with the existing 100KW system, give the Club a 414KW system which is expected to provide around 27% of the power required to run the Club. However, at the same time electricity prices will rise by around 40% when the current electricity supply contract finishes at the end of the calendar year.

The Club continues to support local community, charity and sporting groups with over \$230,000 being donated to these groups this past financial year. The Club takes great pride in the support we provide for the local community.

To Chairman Ian Prescott-Smith and the Board of Directors, thank you for your continued support. To our Operations Manager Dan Morris, thank you for your assiduous assistance. To our Finance Manager Tracy Girardot and our administration staff, your efforts, as always, are above and beyond the call of duty and very much appreciated. To our Management team, thank you for setting the service benchmark for all our staff. To our Executive Chef Adam Southwell, our catering operation continues to make a significant contribution to the Club's success and you and your team should be very proud of the reputation our food has deservedly earned. To all our staff that, day in and day out, provide the highest levels of customer service, please accept my sincerest thanks.

On the green our successes have again been many and varied, with the highlight being the inclusion of Aaron Teys in the Australian Jackaroos squad. To Jeremy Henry, Leif Selby, Trevor Wells, Dallas Delatorre and all our bowls officials, players and supporters thank you and go the Gorillas. Details of all our on green success can be found in the Bowls Reports.

To all our members who suffered bereavement during the year, please accept my sincerest condolences

And last but by no means least, to all our members – thank you for your continued support and friendship and I'll see you at the Club.
